The Siouxland Regional Transportation Planning Association (SRTPA) Technical Advisory Committee (TAC) met on Wednesday, June 12, 2024, 1:30 p.m., in person at 6401 Gordon Drive, Sioux City, and virtually via Zoom.

Vice Chairman Tom Rohe called the meeting to order at 1:30 p.m. A quorum was present.

- I. **Approval of the Agenda:** Vice Chair, Tom Rohe, asked if there were any additions or corrections to the June 12, 2024, regular meeting agenda.

*Mark Nahra moved to approve the meeting agenda as presented, seconded by John Meis. Motion carried with all ayes.*

- II. **Approval of the Minutes:** Vice Chair, Tom Rohe, asked if there were any additions or corrections to the May 8, 2024, regular meeting minutes.

*Brian Pearson moved to approve the minutes presented, seconded by Mark Nahra. Motion carried all ayes.*

- III. **Review Monthly Correspondence:** Corinne Erickson discussed projects and activities outlined in the Director's Report included in the meeting packet since the May 8, 2024, meeting.

- IV. **Transportation Improvement Progress Report:** SRTPA TAC voting, and non-voting members and guests provided an update on the progress of transportation improvements currently underway throughout the region.
- V. **FY 2024-2027 Transportation Improvement Program (TIP) Amendments and Administrative Modifications:** Michelle Bostinelos reported that no amendments or modifications were brought forward. No action.

- VI. **Resolution 2025-1 Approval of the FY 2025-2028 Draft Transportation Improvement Program (TIP):** Michelle Bostinelos presented the FY 2025-2028 TIP to the TAC for a positive recommendation to the Policy Board for approval.

*Marka Nahra moved to approve Resolution 2025-1 based on the conditions that TPMS project# 49722: City of Cherokee, Bridge Replacement be moved from 2024 to 2025 and to remove the 2<sup>nd</sup> Pierson project from the 2025-2028 TIP. Motion seconded by John Meis. Roll call vote: Tom Rohe: aye; Mark Nahra: aye; John Meis: aye; Brian Pearson: aye; Kelly Puhrmann: aye. Motion carried (5:0).*

- VII. **Resolution 2025-2 FY 2025 Certification of Compliance for Siouxland Regional Transit System (SRTS):** Michelle Bostinelos presented TAC with Resolution 2025-2 stating that approval certifies that the FY 2025-2028 TIP is prepared in accordance with the requirements of the Federal Transit Administration.

*Brian Pearson moved to approve Resolution 2025-2 as presented, seconded by Kelly Puhrmann. Roll call vote: Tom Rohe: aye; Mark Nahra: aye; John Meis: aye; Brian Pearson: aye; Kelly Puhrmann: aye. Motion carried (5:0).*

- VIII. **2050 Long Range Transportation Plan Draft Chapter 6: Plan Goals and Objectives & Chapter 7: Implementing the Plan:** Regional Planner, Nate Kistner, presented the TAC with Chapter 6 and 7 of the 2050 Long Range Plan for review and discussion. Nate noted the final LRTP will be brought forward for approval at the November meeting.
